

We realize that you may consider that two of the statements in any one section relate to you, but please check just one which most clearly describes your problem.

Section 1: Pain Intensity

 \Box I can tolerate the pain I have without having to use pain killers.

- □ The pain is bad but I manage without taking pain killers.
- □ Pain killers give complete relief from pain.
- □ Pain killers give moderate relief from pain.
- □ Pain killers give very little relief from pain.

Section 3: Lifting

Section 5: Sitting

Section 2: Personal Care

Section 7: Sleeping
